



# Sandbox VR Gaming League Rules

📍 Location: Gulf Coast Town Center, Fort Myers

🎮 Outrun the Dead. Outplay the Living.

## 1. League Overview

The Sandbox VR Gaming League is a competitive and recreational event series designed to bring together players of all skill levels for thrilling virtual reality experiences. All participants are expected to compete with integrity, uphold sportsmanship, and have fun while immersing themselves in Sandbox VR adventures.

The first seasonal league will start approximately the first week of September. Each season lasts 10 weeks: 8 weeks of regular matches, 1 week of playoffs, 1 week break/registration. Each team will consist of 4 players. We are planning for four seasons leagues per year: Spring, Summer, Fall, Winter

## 2. Eligibility

- Players must be 18 years or older.
- All participants must sign a league participation waiver before competing.

## 3. Registration

- Teams must register prior to the league start date.
- Entry fees must be paid before the first match.
- Teams may use substitutes but must register them before the match begins.

## 4. Game Modes

- Games played will be Deadwood Phobia, AmberSky, Deadwood Valley and Deadwood Mansion
- Games for each week will be announced one week in advance.
- All games will be played at Sandbox VR Gulf Coast Town Center Mall location.

## 5. Prizes

- 1<sup>st</sup> 🏆 Prizes - top scoring team will be awarded – \$300 to \$500.00 (Based on participation level and to be divided by team members). Plus, **each team** member will get two free VR guest tickets for one session.
- 2<sup>nd</sup> 🏆 Prize – **Each team** member will be awarded two free VR guest tickets for one session.
- 3<sup>rd</sup> 🏆 Prize – Sandbox VR swag for each team member

## 6. Cost

- Registration fee is \$40.00 per player. Registration fees must be paid at registration.
- Gaming fee for 8 weeks and 1 tournament week is \$450 (approximately \$45 per game). A minimum of fifty percent (50%) of the game fee must be paid at registration. If not paid in full, remaining 50% is due at the end of the fourth week.

## 7. Scoring

- Points are based on in-game performance top individual Scores, Kills, Accuracy and Mission Status (if applicable).
- Score is calculated with the following formula
  - + The top three individuals scores will be added together (4<sup>th</sup> will be dropped)
  - + Total kills for top three score individuals will be added together
  - + Mission Complete Phobia, Valley, Mansion and AmberSky, – 5,000
    - For Deadwood Phobia Mission Points
      - -1,000 Mission Fail, +1,000 Mission Incomplete

## 8. League Standings

- Standings are updated weekly
- League standings will be posted on leader board within Sandbox VR Fort Myers.
- Top three individual scores will be displayed on leader board

## 9. Player Conduct

- No cheating, exploiting, or tampering with equipment.
- No physical aggression or intentional interference with another player's experience.
- Respect staff and other players at all times.
- Any unsportsmanlike conduct may result in point penalties or disqualification.

## 10. Equipment & Safety

- All equipment will be provided and maintained by Sandbox VR staff.
- Players must follow all safety instructions given by the Game Master (GM).
- Any damage to equipment caused by intentional misuse may result in financial liability.

## 11. Scheduling & Attendance

- Matches start promptly at the scheduled time.



- Teams more than 10 minutes late will forfeit that match.
- Make-up matches may be arranged at the discretion of league organizers.

## 12. Disputes & Rulings

- All disputes must be reported to the league organizer within 15 minutes of match completion.
- The organizer's decision is final and binding.

## 13. Media & Promotion

- By participating, players consent to the use of their image, gameplay footage, and name in league promotions and marketing.

## 14. Amendments

- The league organizers reserve the right to update or modify these rules at any time.
- Any rule changes will be communicated to all players in advance.
